Jonathan Davis, 100 Acres. State of North Carolina, November 11, 1851

To all to whom these presents shall come, Greeting:

Know ye that we for and in consideration of the sum of 30 Shillings for every hundred acres hereby granted, paid into our Treasury by Jonathan Davis have given and granted and by these presents do give and grant unto the said Jonathan Davis a tract of land containing one hundred acres lying and being in the County of Surry beginning at a Beech on the bank of a branch in the fork of Buck Creek and running East thirteen chains and 40 links crossing the Creek to a pine. North eight chains and fifty links to a pine, East six chains and fifty links to a pine, North forty five chains and twenty eight links to a pine, West nineteen chains and ninety links to a pine, South to the beginning.

Entered the 15th day of August 1794 as by the plat hereunto annexed both appears; together with all woods, waters, mines/minerals, hereditaments and appurtenances to the said land belonging or appertaining. To hold to the said Jonathan Davis his heirs and assigns for ever yielding and paying to us such sum of money yearly or otherwise unto our General Assembly from time to time may direct, provided always that the said grantee shall cause this grant to be registered in the Registrar's Office of our said County of Surry within twelve months from the date thereof, otherwise the same shall be void and of no effect. In Testimony whereof we have caused these our letters to be made patent and our great Seal to be hereunto affixed.

This land was probably near Yadkinville, Yadkin County, North Carolina, 20 miles west of Winston-Salem.
Originally part of Surry County.
